### **Essential Qualification:-**

#### **Lecturer/PTI/Librarian**

Master Degree in relevant subject with at least 55% marks ( 50% excluding any grace marks, in case of SC/ST/Differently abled) with NET/SET/SLET or Ph.D.

#### **Teaching Assistant**

Master Degree in relevant subject with atleast 55% marks (50% excluding any grace marks, in case of SC/ST/Differently abled)

Note: In case, relevant qualifications Ph.D/M.Phil/NET/SET/SLET candidates are not available, only then teaching assistants will be engaged.

### **Other terms and conditions**

1. Applicants should be domiciles of JK UT.
2. Applicants can apply for the above positions through an online portal available at College Website ([www.gcwparade.in](http://www.gcwparade.in)) i.e 14<sup>th</sup> of May 2022 to 23<sup>rd</sup> of May 2022 (both days inclusive).
3. The subject wise merit list shall be prepared as per the guide lines notified vide Govt. Order No. 46-JK (HE) of 2022 dated 28-02-2022 and engagement of the short listed candidates shall be made as per the notification.
4. All the notifications regarding the process of engagements shall be available on the website and no individual communications with regard to the engagement process shall be done.
5. In case two or more candidates of the same subject score same points, the candidate having higher marks percentage in PG shall be given first preference and if the tie still persists, it shall be resolved on the basis of UG marks. In case tie persists at UG marks, age of the applicant shall be considered.
6. All Academic Arrangements shall automatically terminate at the end of the academic session 2022-23. The engagements shall be for one academic session, excluding terminal holidays.
7. The lower merit candidate in the concerned subject merit list gets automatically disengaged due to filling up of post by selection through PSC or by posting of regular faculty or change in workload etc.,
8. **A candidate who has been selected in GCW Parade College under academic arrangement for a particular academic session shall not be permitted to join any other Institution/College under the same scheme in the same academic session.**
9. The candidates having been awarded grades in CGPA in any degree / examination for which credits are to be given for calculation of merit, candidate shall enclose a conversion certificate (from CGPA to percentage) from the concerned University.
10. A teaching assistant may be engaged only if no eligible/qualified candidate for lecturer (Academic Arrangement) is available in the concerned subject.
11. The candidates will have to sign an agreement with the Principal of the College, before joining, in the prescribed format, duly attested by 1<sup>st</sup> Class Judicial Magistrate.
12. **The candidates shall have to provide their active email IDs and their working contact**
